## **Best Fabrications, Inc. – Commercial / Patrol / Military Limited Warranty**

Best Fabrications, Inc. offers a 1500 hour (tach-time), or one-year limited warranty (whichever comes first), against tank defects resulting from our manufacture. *The warranty period begins at the date of original invoice or at zero hours tach-time.* This warranty applies to *all* commercial vessels, as well *all* foreign and domestic military and patrol boats. In situations where this warranty applies, Best Fabrications will, at its option, repair or replace the defective product.

The express, written authorization of Best Fabrications, Inc. is required for all warranty claims.

Best Fabrications, Inc. does not warranty or guarantee accessories or components supplied with our tanks, since they are not of our manufacture. Sending units are covered by their own manufacturer's warranty only. Best Fabrications *cannot be held responsible* for any costs or damages incurred by the customer during removal and/or repair of any defective tank, as all tanks are sold as a single unit and warranted as such. If such damages occur, and it is determined to be a *direct* result of defective Best Fabrications, Inc. manufacture, Best Fabrications will review the facts and may negotiate these damages *on a case-by-case basis*. In any such event, Best Fabrications, Inc. must be immediately notified of any potential warranty claim, and must give written authorization before any attempt to modify, remove, or otherwise repair is made.

Any removal, repair, modification, or other tampering of any tank that may be subject to this warranty, prior to the express written notification of Best Fabrications, Inc., will cause this warranty to be void.

Although required tank pressure testing is conducted at Best Fabrications, the customer is also responsible for pressure testing tanks, as well as the entire fuel system, as required under 33 CFR 183.510. Use of an adequate, serviceable in-line fuel filter / strainer is required, or this warranty may be void.

This warranty is void if product damage or failure results from, or is attributed to, improper or faulty installation, product misuse or abuse, modifications not pre-authorized by Best Fabrications, Inc., corrosion, accidents, or questionable inspection, removal, and/or replacement procedures. *This warranty does not cover failure attributed to, or suspected to be caused by, Acts of War, Acts of Terrorism, Domestic Disturbance, or Vandalism.* The use of any fuels other than standard gasoline or diesel blends may also void this warranty. *Use of ethanol / gasoline blends of more than 15% ethanol (E15), bio-diesel blends of more than 20% bio-diesel, or any other alternative fuels will cause this warranty to be void, unless the product was specifically designed for such contents.*

### Extended Warranty Policy Information:

*Extended, Five-Year limited warranty policies must be purchased, at an additional cost, at the time of original purchase of the tank(s) which are to be covered under said policy. Extended, Five-Year Warranty Policies consist of the original, one-year warranty period, plus an additional four years of coverage (Five years total or 6,000 hours tach-time – whichever comes first). Extended warranty pricing varies depending on tank model. Pricing is available through the Best Fab Inc. sales department. All terms and conditions of the standard, "Limited Warranty Policy for Tanks" must be met in order for Best Fabrications, Inc. to honor any claims under the Extended, Five-Year Warranty Policy.*
